## **Selected Works in Progress**

"The Voyage of the *Samannud*." By following an epic and troubled voyage of the Egyptian naval vessel *Samannud* in 1865, this article will shed light on the changing experience of Muslim pilgrimage travel for North Africans and Egyptians in the middle of the nineteenth century, amidst the interplay of steam power, disease, and multiple imperialisms.

*Ottoman Public Debt: A Problem of Knowledge.* This book-length project aims to reinterpret the Ottoman and Ottoman-Egyptian bankruptcies of the 1870s, and the forms of European financial oversight that they introduced in Istanbul and Cairo. Drawing on approaches from science and technology studies, I seek to understand how the knowledge required to manage Ottoman public debt was a product of negotiation among multiple Ottoman and European social groups. The book will explore the consequences of this negotiation for the emergence of modern accounting in the Middle East, and for the global regime of sovereign debt that dates to this period.
